March 2017

October 2017

October 2017

Assembly motion: **The Vermont Area Assembly agrees to adopt the WSO Conventions Guidelines (G-20) as the foundation guideline for sponsoring a Vermont Area Convention.** Unanimously approved.

Assembly motions:

Add \$200 for the 2nd attender. not seconded.

Eliminate \$300 from line 29. 21 voting member; 2/3 is 14; 10 vote yes. motion fails.
